16. Case analysis.

Aircraft maintenance engineer of Indian Air Lines Corporation formed the bulk of engineers having AME license. The recent pay revision announced by Government has resulted wide disparity between wages and allowance between engineers and pilots. Engineers accordingly joined together and formed the union and got it registered. Nearly 90% of serving engineers are joined in the union.

During the recent negotiation with the management, engineers insisted to introduce a clause to make union membership mandatory to all employed engineers, which in other words called 'Union Shop'.

A section of union leaders preferred 'maintenance ship' characteristics to their union where as some others insisted an 'agency-shop' status. Opinions are also dividend whether they should get themselves affiliated to National Union. They decided to seek the opinion of a consultant.
